### **PRESCHOOL FEES from September 2025**

The following is a schedule of the Preschool Fees, which are effective from September 2025.

1. Invoices are produced on a half termly basis and must be paid within 14 days of receipt.
2. A term's notice is required for the removal of a pupil from the Preschool or a charge may be agreed at the Preschool's discretion.
3. Preschool fees will be review each April for the following September and any changes will be notified in writing.
4. The Priors Preschool does not request a deposit to secure a place.
5. There are no admin fees applied to non-funded hours.

**The Priors School does offer Wraparound Care and this can be booked through the school's payment system ParentPay:**

- A £2.60 lunch charge is applied for all children, and should be booked through our external caterer, FreshStart. If you do not wish for your child to have a cooked lunch they may bring a packed lunch.
- Extra hours by arrangement will be charged at £5.75 per hour.
- Open 38 weeks a year (excluding Bank Holidays) and follows The Priors School's term dates.
- The Priors Preschool currently accepts childcare vouchers from a number of providers and is signed up to the Tax Free Childcare Scheme.

# Free Entitlement

## 15 Hours Universal Entitlement

Every child becomes eligible for 15 hours of Universal Entitlement in the term following their 3<sup>rd</sup> birthday until they transfer into state education.

## 30 Hours Extended Entitlement

The additional 15 hours extended entitlement is aimed at working parents and will be means tested (by HRMC, not The Priors Preschool). The following website provides information for parents regarding eligibility and how to apply:

After applying, and if successful, parents need to provide the Preschool with their unique code and the parent's NI number at least 6 weeks before the beginning of the term to which it applies.

## Early Years Pupil Premium

The Priors Preschool may be able to claim extra funding to enhance the quality of your child's early education.

Your child will be eligible for the Early Years Pupil Premium if you are in receipt of one or more of the following benefits or credits:

- Income Support
- income-based Jobseekers Allowance
- income-related employment and support allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of State Pension Credit
- Child Tax Credit, but not Working Tax Credit, with an annual gross income of no more than £16,190
- Working Tax Credit run-on – paid for four weeks after you stop qualifying for Working Tax Credit
- Universal Credit – if the child is born on or after 1 January 2015 and the parent is entitled to Universal Credit, they must have an annual net earned income equivalent to and not exceeding £7,400, assessed on up to three of the parent's most recent Universal Credit assessment periods.

OR the child has:

- been looked after by the local authority for at least one day
- been adopted from care
- left care through special guardianship
- a child arrangement order
